The board problem

Boards are accountable for risks they cannot fully see. Management reporting is often summarised, optimistic, or incomplete. Audits provide periodic snapshots rather than continuous truth. When incidents occur, the question is always the same: **What did the Board know - and when?**

Filtered reporting Optimistic summaries can hide operational reality and uneven adoption.	Audit snapshots Point-in-time reviews miss cultural, behavioural and process drivers.
Evidence expectations Directors need defensible assurance for regulators, auditors and investors.	Incident exposure After failure, “what did you know?” becomes a governance question.
